ORDER:

In the Government orders first read above, orders were issued enhancing Leprosy Allowance to Medical and Para-Medical staff working under National Leprosy Eradication Programme based on the recommendations of Pay Revision Commission, 2005.

2. In the Government Order second read above, based on the recommendations of One Man Committee, 2006 orders were issued to extend the same to Health Education Officer (Leprosy).

3. In the Government Order third read above, orders were issued introducing Revised Scales of Pay based on the recommendations of the Ninth Pay Revision Commission to the State Government Employees.

4. The Ninth Pay Revision Commission, recommended for enhancement of Leprosy Allowance working under the Department of Health.

5. Government have accepted the recommendations of the Ninth Pay Revision Commission and hereby order that the amount of Leprosy Allowance be enhanced to the various categories of posts shown below as stated against each category of post.
