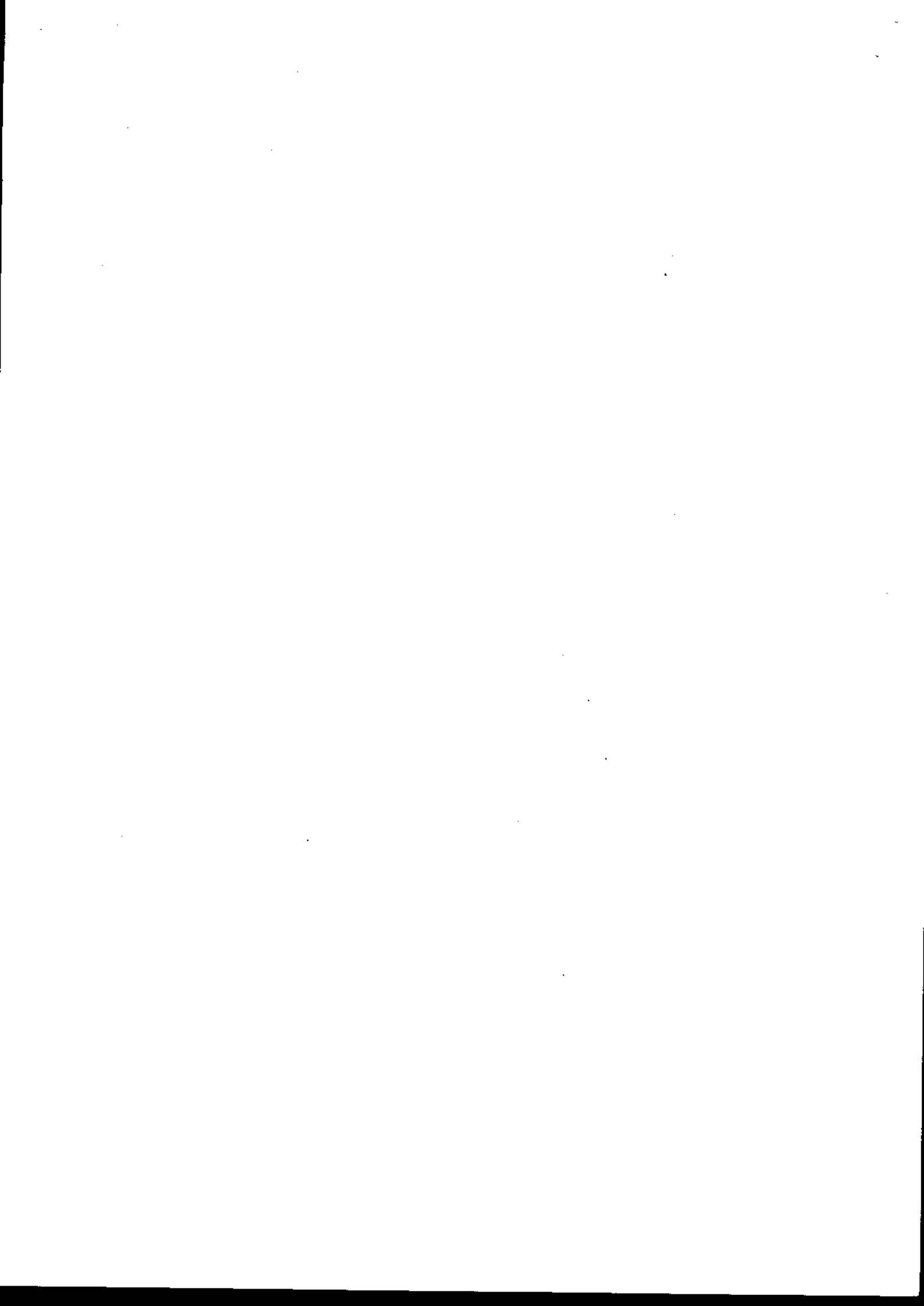
In pursuance of the instructions issued by the Government from time to time, the revised confirmed seniority list of Deputy Executive Engineers of Zone-III in Annexure-A, B and C i.e. from the panel year 1975-76 to 1982-83 in Annexure-A, from the panel year 1983-84 to 1997-98 in Annexure-B and from the panel year 1998-99 to 2001-02 in Annexure-C were communicated vide this office reference 3<sup>rd</sup> cited, subject to outcome of OAs/WPs/SLPs etc/. if any pending before the Hon'ble A.P. Administrative Tribunal/High Court/Supreme Court of India.

Further, the Hon'ble High Court of AP and the Hon'ble APAT have issued judgments for implementation of Rule 16 (h) of AP State and Sub-ordinate Service Rules, 1996.

Further, the Hon'ble High Court of AP also dismissed the WPs filed by the certain PR Engineering personal against the orders issued by the Govt., repatriating them to their respective local cadre in terms of Presidential Order. Accordingly, the Govt., have issued instructions to move all the repatriated persons to their respective local zones and revise the seniority list of all zones as per rules in force.

In view of the above, vide reference 4<sup>th</sup> cited, the confirmed seniority list of Assistant Executive Engineers, PR of Zone.III was revised and confirmed duly applying penal clause 16 (h) of AP State Sub-Ordinate Service Rules, 1996 & repatriations as per G.O.610.

Based on the above confirmed seniority list of Assistant Executive Engineers, PR of Zone.III, dated.18.07.2013, a revised provisional seniority list of Deputy Executive Engineers, PR of Zone.III for the panel years from 1975-76 to 1999-2000 is prepared in supercession of the earlier seniority lists of Deputy Executive Engineers, PR of Zone.III published so far and communicated vide reference 5<sup>th</sup> cited.



As per orders of the Hon'ble Tribunal, dated.29.06.2011 in OA No.1079/2008 and OA No.1082/2008 filed by Sri.Y.Bhagyaraju & (05) others and Sri.K.Amarnath Reddy & (11) others respectively, the Government vide reference 6<sup>th</sup> cited, had directed to implement the upgradation without weightage from 1987 i.e., from the date on which the service rules are amended, in respect of the AEEs upgraded in terms of G.O.Ms.No.552, PR&RD (Estt.III) Department, dated.16.05.1978 and G.O.Ms.No.662, PR&RD (Estt.III) Department, dated.24.11.1987.

Accordingly, vide reference 7<sup>th</sup> cited, a revised provisional seniority list of Assistant Executive Engineers of Zone-III has been communicated duly calling the objections from the individuals concerned. After examining the objections received, the said seniority list has been confirmed and communicated vide reference 8<sup>th</sup> cited.

The provisional seniority list of graduate Deputy Executive Engineers of Zone-III has been communicated for the panel years from 1975-76 to 1999-2000 vide reference 9<sup>th</sup> cited with reference to the confirmed seniority list of Assistant Executive Engineers of Zone-VI vide reference 8<sup>th</sup> cited and carry forwarding all the Deputy Executive Engineer vacancies meant for Direct recruitment from the panel years 1983-84 to 1998-99 i.e., up to the Service rules issued in G.O.Ms.No.15, PR&RD (Estt.II) Department, dated.08.01.1999 and released as on the date of the said G.O.

In response to the above, certain Engineering officers have filed objections, which are discussed and disposed off as follows.

**I) S.Subrahmanyam, Dy. Executive Engineer, PR, Project Sub Division, Repalle, Guntur Dist.**

He has submitted his objections that

- a) His Date of Birth has been changed from 01.02.1962 to 15.04.1940
- b) Though he is in service, in the Status column it was mentioned as "Retired".
- c) His date of regularization was mentioned as 30.06.1997 in the Memo No. Ser.III(1)/7703/2013, dated. 08.08.2013. But in the memo, dated. 19.10.2013, the date of regularization was mentioned as 08.01.1999.

In this connection, regarding objections (a) & (b), it is to submit that due to typographical error, the date of birth was mentioned wrongly as 15.04.1940 instead of 01.02.1962 and the status was mentioned as "Retired" instead of Dy. EE and the above typographical error was already rectified in the "Erratum" issued vide Memo No. Ser.III(1)/7703.2013, dated.28.10.2013 and will be corrected in the confirmed seniority list.

Regarding objection (c) It is to submit that As per the service rules issued for Andhra Pradesh Panchayat Raj Engineering Services Special Rules vide G.O.Ms.No.291, Plg & PR (Estt.I) Dept., dt.23.03.1963 and G.O.Ms.No.1267, PR (SPF) Dept., dt.16.12.1986, there was channel of direct recruitment to the post of Assistant Engineer now re-designated as Deputy Executive Engineer.

Vide G.O.Ms.No.305, Irrigation and Command Area Development (Ser.IV.I) Department, dated.20.11.199, it was decided to dispense with direct recruitment to the second level Gazetted post of Deputy Executive Engineer in all the Engineering

Departments in the state duly stating that necessary action is being taken for the amendment of Special Rules for the Andhra Pradesh Engineering Services for dispensing with direct recruitment to the second level post of DEE in the Irrigation and CAD department and similar action may be taken by Transport, Roads & Buildings, Municipal Administration and Urban Development and Panchayat Raj & Rural Development Departments in respect of Engineering Services under their control. Accordingly, vide G.O.Ms.No.15, PR&RD (Estt.II) Dept., dated.08.01.1999, Government had issued new service rules for A.P.Panchayat Raj and Rural Development Engineering Service Special rules, in supercession of the earlier service rules, in which the channel of direct recruitment provision has not been provided.

The posts meant for Direct Recruitment to the post of Deputy Executive Engineers were filled by direct recruitment up to 1982-83 panel years and the unfilled vacancies meant for Direct Recruitment posts were carried forward to the subsequent panel year i.e., 1983-84 and filled by promotions from the feeder categories of Assistant Executive Engineers and Assistant Engineers/DM Grade.I. The posts meant for direct recruitment to the post of Deputy Executive Engineers from the panel years 1984-85 to the date of new service rules issued in G.O.Ms.No.15, PR&RD (Estt.II) Dept., 08.01.1999, were filled by promotion from the feeder categories without carry forwarding every year previously. This should not be done as the posts meant for Direct Recruitment only.

As such, all the vacancies meant for direct recruitment posts of Deputy Executive Engineers from the panel years 1983-84 to 1998-99, i.e., up to the date of issue of service rules issued in G.O.ms.No.15, dated.08.01.1999, are carry forwarded and all the said vacancies are released as on the date of issue of service rules and the same are filled from the feeder categories of AEE, AE/DM.I as per cycle.

**II) B. Sivarama Krishna, Executive Engineer, V&QC Division, Vijayawada, Krishna District.**

He has submitted his objections as follows:

- 1) Date of birth was wrongly mentioned as 30.07.1957 instead of 20.07.1957 and enclosed the Xerox copy of relevant SR page.

In this connection, it is to submit that in all the earlier seniority lists communicated during the year 2007 onwards, the date of birth was mentioned as 30.07.1957 and the same was repeated in the present provisional seniority list and the same will be corrected in the confirmed seniority list.

- 2) Where there is no selection/notification of PSC-84 AEES in Zone-III, how certain AEEs of PSC-84 belongs to other zones were shown in Zone-III above him, by which he became junior.

In this connection, it is to submit that during repatriation of AEEs of other zones to their local cadre as per G.O. 610, their seniority has to be protected and placed at the appropriate places as per their date of commencement of probation in their appointed zone from which they were transferred and also as per para (c) (v) of rule 38 of A.P.S.S.S.Rules 1996, the seniority of any member of the service who is so transferred on administrative grounds shall be fixed in the unit to which he is transferred with reference to the date of his appointment in the office from which he is transferred. As such,

they were placed in the seniority list at appropriate place with reference to their commencement of probation in their appointed zones.

- 3) Certain AEEs possessing PG Qualification were shown as seniors to him in the memo dated. 19.10.2013. But in the seniority list, dated. 08.08.2013, they are shown as juniors to him.

In this connection, it is to submit that due to recasting of occurrence of vacancies, duly carry forwarding the Direct Recruitment Vacancies to the panel year 1998-99, as per Service Rules issued vide G.O.MS.15, dated. 08.01.1999, and down placing the Upgraded AEEs.as per the orders of the Government and placing them w.e.f. 24.11.1987, (2) Juniors i.e., Sri K. Prabhakar Reddy and Sri A. V. Subrahmanyam were placed above him against PG Points, as per their eligibility.

- 4) He has objected for placing the seniority list in PRED Website, without communicating hard copy which is against rules.

In this connection, it is to submit that the provisional seniority list of Gr. Dy. Executive Engineers was placed in PRED Website, which is official Website of PR Engineering Department, and the official communications are being placed in the Website, where it is necessary and considered official and valid. Moreover concerned Superintending Engineers, PR were instructed to download the memo along with annexure and display in their Notice Boards of Circle & Division Offices.

**Objection Nos. 5 to 10:** He has objected that his name was shown in the panel year 1994-95 in the list dated 27.11.2009 and now it was shown in the panel year 198-99, due to which he lost 4 panel years and pushed down in the seniority. The carry forwarding of the vacancies was done without any instructions from Government and any requisition from the individuals. If the Direct Recruitment vacancies have been notified from time to time, he might have appeared/selected for the above post and the same is with others also. Further, he objected that when the Government banned Direct Recruitment of Dy.EEs. in the earlier occasions in all sister Engineering Departments including PRED, how the vacancies were released at a stretch from 1983-84 to 1998-99, which is irregular and against rules. Carry forwarding the DR Vacancies at this juncture i.e., after gap of 20 years is not at all giving any benefit to the in-service candidate. Further he objected that as per Rule 16 (a) & 13(A) of APSSR, 1996, the actual date of promotion should be taken for further promotions to the post of EE, but the same was not done and occurrence of vacancies were shown as dates of regularization, which are earlier than the actual dates of promotion in certain cases.

In this connection, it is to submit that As per the service rules issued for Andhra Pradesh Panchayat Raj Engineering Services Special Rules vide G.O.Ms.No.291, Plg & PR (Estt.I) Dept., dt.23.03.1963 and G.O.Ms.No.1267, PR (SPF) Dept., dt.16.12.1986, there was channel of direct recruitment to the post of Assistant Engineer now re-designated as Deputy Executive Engineer.

Vide G.O.Ms.No.305, Irrigation and Command Area Development (Ser.IV.I) Department, dated.20.11.199, it was decided to dispense with direct recruitment to the second level Gazetted post of Deputy Executive Engineer in all the Engineering Departments in the state duly stating that necessary action is being taken for the amendment of Special Rules for the Andhra Pradesh Engineering Services for dispensing with direct recruitment to the second level post of DEE in the Irrigation and CAD department and similar action may be taken by Transport, Roads & Buildings, Municipal Administration and Urban Development and Panchayat Raj & Rural Development Departments in respect of Engineering Services under their control. Accordingly, vide G.O.Ms.No.15, PR&RD (Estt.II) Dept., dated.08.01.1999, Government had issued new service rules for A.P.Panchayat Raj and Rural

Development Engineering Service Special rules, in supercession of the earlier service rules, in which the channel of direct recruitment provision has not been provided.

The posts meant for Direct Recruitment to the post of Deputy Executive Engineers were filled by direct recruitment up to 1982-83 panel years and the unfilled vacancies meant for Direct Recruitment posts were carried forward to the subsequent panel year i.e., 1983-84 and filled by promotions from the feeder categories of Assistant Executive Engineers and Assistant Engineers/DM Grade.I. The posts meant for direct recruitment to the post of Deputy Executive Engineers from the panel years 1984-85 to the date of new service rules issued in G.O.Ms.No.15, PR&RD (Estt.II) Dept., 08.01.1999, were filled by promotion from the feeder categories without carry forwarding every year previously. This should not be done as the posts meant for Direct Recruitment only.

As such, all the vacancies meant for direct recruitment posts of Deputy Executive Engineers from the panel years 1983-84 to 1998-99, i.e., up to the date of issue of service rules issued in G.D.ms.No.15, dated.08.01.1999, are carry forwarded and all the said vacancies are released as on the date of issue of service rules and the same are filled from the feeder categories of AEE, AE/DM.I as per cycle.

11) He objected that the seniority lists are revised frequently from time to time every year and twice or thrice in a single year, which is creating mental agony to him and also to others.

In this connection, it is to submit that because of implementation of G.O. 610 and Rule 16 (h)/down placing the upgraded AEEs.with effect from 24.11.19887, based on the instructions of the Government from time to time and in view of the orders of the Hon'ble Courts, the seniority lists are revised.

### **III. E. Venugopal Reddy, Dy. EE, Y.Palem, Prakasam District**

He has submitted that he is having M.Tech. Qualification and requested to change his qualification from B.Tech. to M.Tech. and to place him in the Dy. Exe. Engineer's seniority list in between Sri A. Omkaram (Sl.No. 115) and Sri K. Sivarama Kumar (Sl.No. 116)

In this connection, it is to submit that he was not placed in the seniority list of Dy. Executive Engineers, as he has not come up for zone of consideration upto 2001-2002 Panel Years. He will be placed at the appropriate in the subsequent panel years, as per his turn. Regarding M. Tech. Qualification, he has submitted only Xerox copy of provisional certificate, which is not authenticated.

Hence, he may be requested to submit attested copy of P.G. Degree certificate along with copy of relevant page of S.R., where his PG Degree is entered.

### **IV. K. Siva Kumar, DEE, V&QC Sub Division, Markapur, Prakasam Dist.**

He objected that that his name was lowered from the panel year 1995-96 to 1998-99 for which he is losing his opportunities for promotion to higher posts. He further objected that carry forward the posts of Direct Recruitment for 16 years is irregular and as such the Direct DEEs cannot be carried forward beyond 3 years and shall be filled with any other eligible candidates after 3 years as per procedure in the department and due to the above carry forward, his sub juniors in other zones are being placed above his position in integrated seniority list being prepared.

In this connection, it is to submit that As per the service rules issued for Andhra Pradesh Panchayat Raj Engineering Services Special Rules vide G.O.Ms.No.291, Prg & PR (Estt.I) Dept., dt.23.03.1963 and G.O.Ms.No.1267, PR (SPF) Dept., dt.16.12.1986, there was channel of direct recruitment to the post of Assistant Engineer now re-designated as Deputy Executive Engineer.

Vide G.O.Ms.No.305, Irrigation and Command Area Development (Ser.IV.I) Department, dated.20.11.199, it was decided to dispense with direct recruitment to the second level Gazetted post of Deputy Executive Engineer in all the Engineering Departments in the state duly stating that necessary action is being taken for the amendment of Special Rules for the Andhra Pradesh Engineering Services for dispensing with direct recruitment to the second level post of DEE in the Irrigation and CAD department and similar action may be taken by Transport, Roads & Buildings, Municipal Administration and Urban Development and Panchayat Raj & Rural Development Departments in respect of Engineering Services under their control. As such, all the vacancies meant for direct recruitment posts of Deputy Executive Engineers from the panel years 1983-84 to 1998-99, i.e., up to the date of issue of service rules issued in G.O.ms.No.15, dated.08.01.1999, are carry forwarded and all the said vacancies are released as on the date of issue of service rules and the same are filled from the feeder categories of AEE, AE/DM.I as per cycle.

**V. S. Subrahmanyam, Dy.E.E.,PR, PIU Sub Division, Repalle, Guntur Dist.**

- 1) Where there is no selection/notification of PSC-84 AEEs in Zone-III, how certain AEEs of PSC-84 belongs to other zones were shown in Zone-III above him, by which he became junior.

In this connection, it is to submit that during repatriation of AEEs of other zones to their local cadre as per G.O. 610, their seniority has to be protected and placed at the appropriate places as per their date of commencement of probation in their appointed zone from which they were transferred and also as per para (c) (v) of rule 38 of A.P.S.S.S.Rules 1996, the seniority of any member of the service who is so transferred on administrative grounds shall be fixed in the unit to which he is transferred with reference to the date of his appointment in the office from which he is transferred. As such,

they were placed in the seniority list at appropriate place with reference to their commencement of probation in their appointed zones.

- 2) Certain AEEs possessing PG Qualification were shown as seniors to him in the memo dated. 19.10.2013. But in the seniority list, dated. 08.08.2013, they are shown as juniors to him.

In this connection, it is to submit that due to recasting of occurrence of vacancies, duly carry forwarding the Direct Recruitment Vacancies to the panel year 1998-99, as per Service Rules issued vide G.O.MS.15, dated. 08.01.1999, and down placing the Upgraded AEEs.as per the orders of the Government and placing them w.e.f. 24.11.1987, (2) Juniors i.e., Sri K. Prabhakar Reddy and Sri A. V. Subrahmanyam were placed above him against PG Points, as per their eligibility.

- 3) He has objected for placing the seniority list in PRED Website, without communicating hard copy which is against rules.

In this connection, it is to submit that the provisional seniority list of Gr. Dy. Executive Engineers was placed in PRED Website, which is official Website of PR Engineering Department, and the official communications are being placed in the Website, where it is necessary and considered official and valid. Moreover concerned Superintending Engineers, PR were instructed to download the memo along with annexure and display in their Notice Boards of Circle & Division Offices.

**Objection Nos. 4 to 9:** He has objected that his name was shown in the panel year 1996-97 and now it was shown in the panel year 198-99, due to which he lost 4 panel years and pushed down in the seniority. The carry forwarding of the vacancies was done without any instructions from Government and any requisition from the individuals. If the Direct Recruitment vacancies have been notified from time to time, he might have appeared/selected for the above post and the same is with others also. Further, he objected that when the Government banned Direct Recruitment of Dy.EEs. in the earlier occasions in all sister Engineering Departments including PRED, how the vacancies were released at a stretch from 1983-84 to 1998-99, which is irregular and against rules. Carry forwarding the DR Vacancies at this juncture i.e., after gap of 20 years is not at all giving any benefit to the in-service candidate. Further he objected that as per Rule 16 (a) & 13(A) of APSSR, 1996, the actual date of promotion should be taken for further promotions to the post of EE, but the same was not done and occurrence of vacancies were shown as dates of regularization, which are earlier than the actual dates of promotion in certain cases.

In this connection, it is to submit that As per the service rules issued for Andhra Pradesh Panchayat Raj Engineering Services Special Rules vide G.O.Ms.No.291, Plg & PR (Estt.I) Dept., dt.23.03.1963 and G.O.Ms.No.1267, PR (SPF) Dept., dt.16.12.1986, there was channel of direct recruitment to the post of Assistant Engineer now re-designated as Deputy Executive Engineer.

Vide G.O.Ms.No.305, Irrigation and Command Area Development (Ser.IV.I) Department, dated.20.11.199, it was decided to dispense with direct recruitment to the second level Gazetted post of Deputy Executive Engineer in all the Engineering Departments in the state duly stating that necessary action is being taken for the amendment of Special Rules for the Andhra Pradesh Engineering Services for dispensing with direct recruitment to the second level post of DEE in the Irrigation and CAD department and similar action may be taken by Transport, Roads & Buildings, Municipal Administration and Urban Development and Panchayat Raj & Rural Development Departments in respect of Engineering Services under their control. As such, all the vacancies meant for direct recruitment posts of Deputy Executive Engineers from the panel years 1983-84 to 1998-99, i.e., up to the date of issue of service rules issued in G.O.ms.No.15, dated.08.01.1999, are carry forwarded and all the said vacancies are released as on the date of issue of service rules and the same are filled from the feeder categories of AEE, AE/DM.I as per cycle.

10) He objected that the seniority lists are revised frequently from time to time every year and twice or thrice in a single year, which is creating mental agony to him and also to others.

In this connection, it is to submit that because of implementation of G.O. 610 and Rule 16 (h)/down placing the upgraded AEEs.with effect from 24.11.19887, based on the instructions of the Government from time to time and in view of the orders of the Hon'ble Courts, the seniority lists are revised.

11) He objected that one Mr. A. Chowdaraiah in Seniority list Sl.No. 64 is not available in the department for the last few years and his name is placed in the seniority list every time and requested to take action to remove the name of the individual from the seniority list.

In this connection, it is to submit that Sri A. Chowdaraiah was absconded from service w.e.f.12.12.1994 in the cadre of Dy. Executive Engineer and hence, his name was included in the provisional seniority list of Dy. Executive Engineers, duly showing the status as "Absconding".

**VI. Sri V. Kantha Rao, Dy. EE, PR, V&QC Sub Division, Ongole, Prakasam Dist.**

He objected that his date of birth was wrongly mentioned as 24.08.1962 and requested to correct as 20.08.1962. He further objected that his name was spelled as V.Kantarao and requested to correct as V. Kantharao. He also enclosed Relevant page of Service Register and also SSC Marks List.

In this connection, it is to submit as per the enclosed documents, his date of Birth is 20.08.1962 and the name was spelled as V. Kantharao. Hence, his objection may be considered and corrected in the confirmed seniority list.

It is informed that the request has come from all zones to not to carry forward the vacancies of Deputy Executive Engineers meant for Direct Recruitment from the panel year 1983-84 to 2001-2002 and to consider it as was done in the earlier confirmed seniority list of graduate Deputy Executive Engineer list

communicated vide reference 3<sup>rd</sup> cited. After examining the issue in detail, it is decided to confirm the seniority list of graduate Deputy Executive Engineers without carry forwarding the vacancies of Deputy Executive Engineers meant for Direct Recruitment from 1983-84 panel years.
