ORDER:

The Hon'ble High Court of Andhra Pradesh and A.P.A.T., Hyderabad have delivered judgments on implementation of 16 (h) of AP State and Subordinate Service Rules 1996 in respect of Assistant Executive Engineers those who passed Account Test belatedly.

Accordingly, the Government have issued instructions from time to time to implement the rule 16 (h) of APSSS, 1996 and requested to revise the date of commencement of probation in respect of Assistant Executive Engineers, who passed Account Test belatedly and also to revise the seniority list with reference to the revised date of commencement of probation.

Therefore, vide reference 3rd cited, proposals were submitted to the Government in respect of Assistant Executive Engineers, PR of Zone.IV pertaining to PSC.92, LR.93, UK.90, CERP.91 & Upgraded batches, who passed Account Test belatedly with a request to revise the date of commencement of probation as per Rule 16 (h) of APSSS, 1996, being competent authority.

In turn, the Government vide reference 4th cited, have issued orders revising the date of commencement and declaration of probation in respect of certain Assistant Executive Engineers, PR in the State along with Zone.IV and requested to take necessary action.

In pursuance of the orders of the Government and in supersession of the earlier orders issued regarding commencement of probation and declaration of probation in respect of the following Assistant Executive Engineers, PR of Zone-IV, the date of commencement of probation and declaration of probation are hereby revised due to application of penal clause 16 (h) of A.P State and Subordinate Service Rules 1996 and shown against their names at Column Nos.5 & 6 respectively as follows:


