In compliance to the orders of Hon'ble Courts and orders / instructions of Government, a revised provisional seniority list of Assistant Executive Engineers of Zone-IV covering batches LR-84, PSC-84, GO-413, PSC-86, PSC-89, GO-193 and upgraded AEEs. in supersession of the earlier confirmed seniority list issued vide reference 1st cited, was prepared and communicated by incorporating / deleting the names of A.E.Es. who were transferred to Zone-IV from other zones / transferred to other Zones from Zone-IV under GO-610 and by applying Rule 16 (h) of A.P. State and Subordinate Service Rules 1996 in respect of the AEEs. who passed Account test belatedly vide reference 10th cited.

In response to the above, certain individuals have filed objections, which are discussed and disposed off as follows, duly keeping in view of the latest court directions and Government orders.

Gist of the objections:

All the above officers have raised their objection and requested to delete the upgraded A.E.Es. from the seniority list as per the Hon'ble APAT judgement dated 29.6.2011 in O.A.No. 1079/2008 & 1008/2008 at Sl.Nos.8,9,29,30,31,32,33,34,35,36,37,38,39,113,117,118,135,138,139 and show their names in the seniority list of Assistant Engineers i.e. their original recruitment. They have also mentioned that there are more upgraded AEEs. in the previous list communicated before 1984 batch.

Remarks:

In view of the Hon'ble APAT orders the Govt. were addressed for instructions in the matter. In turn the Govt. in Memo No.10097/Estt.III/A2/2012-3, dt.6.5.2013 of PR&RD Dept. have instructed to comply with the orders of Hon'ble Tribunal and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

In the light of the above instructions the upgraded AEEs are not disturbed in the revised provisional seniority list of AEEs. of Zone-IV.

After examining the objections a decision is taken for addressing the Government for further instructions in the matter. It is also add that the Hon'ble APAT in C.A.No.1577/2012 in O.A.No. 3293/2009 filed by Sri Raghuveera Reddy, Dy.E.E. and others have ordered to prepare the seniority within (4) months from the date of issue of orders. Since the Hon'ble Tribunal fixed the time limit for preparation of seniority there is no option except to finalise the seniority subject to outcome of instructions from Govt. in regard to deletion of names of the upgraded AEEs. from the seniority list.

- II. 1. Sri N.Krishna Reddy, Dy.E.E.(PR) OD in Rural Development, Hyderabad
2. Sri M.Sivaprasad, Dy.E.E.(PR) OD in Rural Development, Hyderabad**

Gist of the objections:

Both the above officers have objected that M.Tech. qualification is not mentioned against their names and they have stated that they have acquired P.G (Master of Science in Sanitary Engg. under environmental Engg. IHE, DELFT, The Netherlands) and the same was entered in their service register. Further, they also pointed out that some of their colleagues in Zone-III with similar P.G. has been considered and included in the list communicated. Therefore they objected for not mentioning their PG Degree against their names and requested to consider their plea for adding the PG qualification against their names.

Remarks:

The P.G (Master of Science in Sanitary Engg. under Environmental Engg. IHE, DELFT, The Netherlands) is not at all equivalent to Master Degree in Engg. and it is only a course in a particular subject viz. Sanitary Engg. offered by Foreign University and not covered all the Engg. subjects in Master Degree of Engg. Hence, the course is treated as Diploma in PG.

Hence, their objection is rejected.

Gist of the objections:

All the above officers have requested the authority to grant them further extension of time of (30) days for submitting their objections after going through the relevant documents which are pertaining to (3) decades.

Remarks:

As per rules in vogue sufficient time of (15) days is allowed for submitting their objections. The Hon'ble APAT has fixed time limit of (4) months to finalise the seniority. Hence, it is not feasible of consideration and their objections were rejected

- IV Sri S.Kanthanath, SE, RWS&S, Visakhapatnam**

Gist of the objection:

He has submitted his objection on his date of commencement of probation duly stating that he has passed Account test for PWD Officers and Subordinates on 14.11.1980 and the same was published in A.P.

Gazette on 30.4.1981. Therefore the date of commencement of probation noted as 2.10.1987 (belated) is not correct. Therefore he has requested to correct the date as 14.11.1980. He enclosed Xerox copy of S.R. entry regarding date of Account Test.

Remarks:

His request is examined and his date of commencement of probation is rectified as 13.7.1984 duly cancelling the belated orders in so far as concerned to him and placed at Sl.No.(6) i.e. below Sri B.Rajendraprasad, AEE of GO-413 batch.

V Sri B.N.Srinivasulu, SE, RWS&S, Chittoor

Gist of the objection:

He has submitted his objection on his date of commencement of probation duly stating that he has passed Account test for PWD Officers and Subordinates on 27.11.1981 and the same was published in A.P. Gazette on 13.5.1982. Therefore the date of commencement of probation noted as 29.8.1994 (belated) in the revised provisional seniority list is not correct. Therefore, he has requested to rectify the seniority. He enclosed Xerox copy of A.P. Gazette in which Account Test result was published.

Remarks:

His request is examined and his date of commencement of probation is rectified as 13.7.1984 duly cancelling the belated orders in so far as concerned to him and he is placed at Sl.No. (12) i.e. above Sri K.Bhagawantha Rao, AEE of GO 413 batch.

VI Sri C.Suryanarayana, SE,PR,Guntur

Gist of the objection:

He has raised his objection that he has passed Account Test for PWD Officers and Subordinates held on 12.6.1987 i.e. within the period of probation and hence he has not come under rule 16(h) of APSSS Rules 1996.

Remarks:

Though the examination held on 12.6.1987 the result was published by APPSC on 04.12.1987. As per rules in vogue the date of passing of Test is the criteria for determining the date of commencement of probation but not the date of examination held.

Hence, his objection is rejected.

VII Sri K.Mahalingappa, Dy.E.E.,O/o SE,PR,Anantapur.

Gist of the objection:

He has objected that the AEEs. whose commencement of probation is beyond 1.4.1993 are shown in the provisional seniority list is not correct and they may be placed after the A.E.Es. whose commencement of probation is 15.3.1992 as was done in Zone-V. Therefore, he requested to the A.E.Es. at Sl.No.144 to 147 of the revised provisional seniority list shall be placed after PSC 1992 batch.

Remarks:

The Hon'ble High Court delivered its judgement dt.27.1.2010 in W.P.No.461/2010 regarding implementation of rule 16(h) of APSSS Rules. In the said judgement the Hon'ble High Court has opined that the position of the belated candidates to be shown in the provisional seniority list with reference to the date of passing of Account test so as to know their position. Hence, the names of the belated candidates at Sl.No.141 to 147 whose commencement of probation fallen on or after 1.4.1993 were shown in the provisional seniority and their names are deleted from the confirmed seniority list and they are informed that their names will be shown w.r.t. the dates commencement of probation assigned to them in the next seniority list to be communicated.

**VIII 1. Sri B.Ravikumar, I/c.SE,PR,Anantapur
2. Sri C.Suryanarayana, SE,PR,Guntur**

Gist of the objections:

- i. the seniority is communicated from 1984 to 1989 only, but not from the inception of the Dept. i.e. from 1971 onwards.
- ii. Sri T.N.Sarnath, PSC (LR) has been repatriated to Zone-I under G.O. 610 and hence his name may be deleted from the seniority list of Zone-IV.
- iii. the upgraded A.E.Es are not deleted from the list as per court orders.

Remarks:

Both the officers belong to GO-413 batch. The A.E.Es. of SQT 1975 batch, LR 1979, GO-647 and upgraded A.E.Es. are shown in the confirmed seniority list in Memo No.SO.IV(1)/ 50597/2005-Zone-IV-1, dt.2.6.2007. All the individuals were appointed as A.E.Es. and their commencement of probation is fallen before 9.3.1981 and they do not come under the purview of 16(h) of APSSS Rules.

In view of the Hon'ble APAT orders the Govt. were addressed for instructions in the matter. In turn the Govt. in Memo No.10097/Esst.III/A2/2012-3, dt.6.5.2013 of PR&RD Dept. have instructed to comply with the orders of Hon'ble Tribunal and to prepare the seniority list by implementing the rule 16(h) of A.P. State and Subordinate Service Rules 1996 within the stipulated time ignoring other aspects.

In the light of the above instructions the upgraded AEEs are not disturbed in the revised provisional seniority list of AEEs. of Zone-IV.

Sri T.N.Sarnath belongs to LR 79 and he was transferred to Zone-II under GO-610. Hence his name is deleted from the confirmed seniority list communicated in Memo No.SO.IV(1)/50597/2005-Zone-IV-1, dt.2.6.2007 and will be shown in the seniority list of Zone-II at appropriate place.

IX Sri P.Raghuramaiah, EE, RWS&S Dvn., Pulivendula

Gist of the objection:

He has objected that Sri P.Sanjeeva Rao, was placed at Sl.No.41 in the seniority list, who was transferred from Zone-V under GO-610, is not correct since the individual was a belated candidate and his revised date of commencement of probation is 13.4.1987 as per Procs.No.SO.II(5)/ 3887/2011, dt.28.5.2013 of E.in.C(PR)Hyderabad and requested to place Sri P.Sanjeeva Rao below him as per rule 16(h). He has also requested to delete the upgraded A.E.Es. as per court orders.

Remarks:

On verification of records, Sri P.Sanjeeva Rao, passed Account test within the probation period and he was shown at Sl.No.41 w.r.t. his date of commencement of probation in the revised provisional seniority of AEEs. of Zone-IV. But he was erroneously shown as belated in Procs.No.SO.II(5)/3887/ 2011, dt.28.5.2013. Hence, his placement as shown in Zone-IV seniority list remains unchanged.

X Sri M.Chandrasekhar Reddy, Dy.E.E., PRI Sub-dvn., Srikalahasti

Gist of the objection:

He has represented to mention his qualification as M.Tech (CS) instead of B.Tech. duly enclosing Xerox copy of M.Tech. (Computer Science) Degree certificate issued by University of Hyderabad.

Remarks:

His request is considered and his M.Tech.(Computer Science) degree is shown against his name

XI Sri Y.Bhagyaraju, Dy.E.E., V&QC Sub-dvn.II, Kurnool**Gist of the objection:**

He has represented that he passed M.Tech. (water resources engg.) during May 2001 and requested to consider his request for incorporate in the seniority duly enclosing attested copy of M.Tech. Degree from JNTU, Anantapur.

Remarks:

As he acquired the M.Tech (Water Resources Engg.) from JNTU during the year 2001 in the cadre of Dy.E.E., the same will be examined and considered from the year 2001 in the integrated seniority of Dy.E.Es.

XII Sri B.Vinaya Kumar, Superintending Engineer, RWS&S, Kadapa.**Gist of the objection:**

He has stated that he was repatriated from Zone-V to Zone-IV under GO 610 and his name has to be shown in the seniority list of AEEs of Zone-IV.

Remarks:

On verification of records it is found that Sri B.Vinaya Kumar, was appointed as AEE through APPSC during 1984 among others in Zone-V, later he was transferred to Zone-IV under GO 610. But his name was not included in the revised provisional seniority list of AEEs. of Zone-IV by oversight. Now his name is included in the confirmed seniority list of AEEs. of Zone-IV and he is placed in between Sri V.Sreeramulu and D.Buggaiah w.r.t. his date of commencement of probation.

Therefore, the Revised Provisional Seniority list of Assistant Executive Engineers of Zone-IV communicated vide reference 10th cited, is hereby confirmed after taking into consideration of above objections.

The confirmed seniority of A.E.Es. of Zone-IV now communicated is subject to outcome of O.As./W.Ps./S.L.Ps., if any, pending before the Hon'ble A.P. Administrative Tribunal / High Court of Andhra Pradesh / Supreme Court of India.
