ORDER:

The Hon'ble High Court of A.P. and A.P.A.T., Hyderabad have delivered judgments on implementation of 16 (h) of AP State and Subordinate Service Rules, 1996 in respect of Assistant Executive Engineers those who passed Account Test belatedly. Accordingly, the Government have issued instructions from time to time to implement the rule 16 (h) of APSSS, 1996 and requested the Engineer-in-chief, PR to revise the date of commencement of probation in respect of Assistant Executive Engineers/Assistant Engineers, who passed Account Test belatedly and also to revise the seniority with reference to the revised date of commencement of probation.

In the reference 5th & 6th cited, proposals were submitted to Government in respect of (95) Assistant Engineers of all Zones, who have passed Account Test belatedly and requested to revise the date of commencement of probation as per Rule 16 (h) of APSSS, 1996. In turn, Government vide reference 7th & 8th cited, have issued orders revising the dates of commencement of probation and declaration of probation in respect of (95) Assistant Engineers of all zones including (29) Assistant Engineers of Zone-VI and requested the Engineer-in-Chief (PR) to take necessary action.

In pursuance of the orders of the Government and in supersession of the earlier orders issued regarding commencement of probation and declaration of probation in respect of the Assistant Engineers (PR) of Zone-VI, the date of commencement of probation and declaration of probation are hereby revised due to application of penal clause 16 (h) of AP State and Subordinate Service Rules, 1996 as shown against their names at Column Nos. (7) & (8) in the enclosed Annexure.
