Sub: Estt. – PRESS – Provisional Inter-se-seniority of Assistant Engineers between Promotees and Direct recruits of Zone-I during 1994-1998 – Communicated – Objections invited – Regarding.

The Hon'ble APAT in the reference 1st cited has passed the orders on 1.11.2011 directing the respondents to finalise the inter-se-seniority between the direct recruits and promoters as per the rules in force within two months. After finalizing the inter-se-seniority list, promotions already effected shall be reviewed and appropriate orders shall be passed according to the rules.

The Government vide references 2nd, 3rd and 6th cited have issued instructions to the Engineer-in-Chief, P.R.Dept., Hyderabad and Engineer-in-Chief, RWS&S Dept., Hyderabad, to finalise the inter-se-seniority between the direct recruits and promotees as per rules in force. And after finalizing the inter-se-seniority list, promotions already effected shall be reviewed and pass appropriate orders in view of the Hon'ble APAT orders and as per rules in force as they are competent authority in the matter.

Keeping in view of the Hon'ble APAT orders and instructions of the Government, a provisional inter-se-seniority list of Assistant Engineers of Zone-I between promotees who were promoted /appointed from the feeder category of Draughtsmen / Work-Inspectors and direct recruits who were selected through A.P. Public Service Commission as per Special Rules issued vide G.O.Ms.No.296, PR&RD and Relief (Estt.II) Dept., dated 20.5.1994 for A.P. Panchayati Raj Engineering Subordinate Service is prepared duly following the quota earmarked for promotions and direct recruitment as per statutory rules in G.O. Ms.NO.296, dt.20.5.1994 and as per the Hon'ble APAT orders dated 17.12.2009 in O.A.No.7702/2006 with MA No.446/2008 filed by Sri R.Ramachander, Assistant Engineer and (25) others and annexed to this memo.

The Assistant Engineers shown at Sl.No.44 to 51 and 53 have not passed Account test for PWD Officers and Subordinates within their prescribed period of probation. Hence, the penal clause 16(h) of A.P. State and Subordinate Service Rules 1996 is invoked, due to which their dates of commencement of probation are provisionally arrived and according to the dates so assigned, their placements are determined in the seniority subject to confirmation by the Govt.

This provisional inter-se-seniority list of Assistant Engineers of Zone-I between promotees and direct recruits is subject to the outcome of S.L.Ps./W.Ps./O.As., if any pending, in the Hon'ble Courts.

The concerned Assistant Engineers are requested to treat this as a notice and file their objections, if any, on the ranks assigned to them in the provisional inter-se-seniority list of Assistant Engineers of Zone-I. Their objections along with authenticated proof in support of their claim, if any, should reach in this office within (15) days from the date of receipt of this memo, failing which it will be construed that they have no objections against their placements in the provisional inter-se-seniority list of Assistant Engineers of Zone-I and further action will be taken to confirm the said provisional seniority list. Any objections filed after the stipulated time will not be entertained under any circumstances.
