The provisional seniority list of Assistant Executive Engineers of zone-V was prepared and communicated vide reference 20th cited, based on the instructions of Govt. and judgment of various courts duly inviting objections if any.

In response to the above certain Assistant Executive Engineers in the seniority list have filed objections which are discussed and disposed as follows.

1.Sri R.Siva Ram, Dy.Executive Engineer: He has stated that he belongs to ST category and recruited under LR 1993 through APPSC not through APPSC 1992 batch. His services were regularized in Zone-II w.e.f 6.5.1993 and under spouse case he was transferred on request from zone-II to zone-V as per G.O.Rt.No. 737 PR&RD dt. 10.06.1997 with a condition to take below the last regular candidate (Accordingly he joined in zone-V on 23-06-1997). Further he submitted that Assistant Executive Engineers who were appointed during 1990-94 were regularized as per G.O.262 dt. 25.06.2006 which is later his joining in Zone V and therefore requested to place his seniority above Sri B.Satyanarayana, Assistant Executive Engineer who was appointed under LR 1993 APPSC.

With regards to the above objection it is informed that R.Siva Ram, formerly Assistant Executive Engineer now Dy. Executive Engineer was transferred on request from zone-II to zone-V as per G.O.Rt.No. 737 PR & RD dt. 10.06.1997 foregoing his seniority in zone-II and with a condition to assigning last rank in the seniority list below the last regular candidate in Zone V and he joined in zone-V on 23.6.1997. Govt. has considered the appointed temporary Assistant Executive Engineers to regularize the services below the last regular Assistant Executive Engineer appointed through APPSC prior to promulgation of Act. 2/1994. But his regularization of service in zone-V will be from the date of joining in the zone-V i.e 23.06.1997. Hence placing him above Sri B.Satyanarayana, Assistant Executive Engineer who joined in the department as per G.O.610, can not be considered.

Hence his request is here by rejected and his name is deleted in the confirmed list now communicated and will be placed at appropriate place in the next list.

2.Sri M.Sai Baba, Dy Executive Engineer:

He submitted that he joined in PRED on 9.9.1991 under CRP programme. Later he was repatriated from zone-III to zone-V under G.O.610. His services were regularized in zone-III on 7.11.1993 and he requested to consider the date of regularization from 14.05.1993 in zone-V along with others appointed in zone-V.

With regards to the above objection he is informed that his request is considered and Assistant Executive Engineers repatriated from other zones were given regularization date as on 14.05.1993 and order of Assistant Executive Engineers repatriated under 610 to zone-V is maintained as per the date of birth with out disturbing their seniority in their respective zones.

3.N.Sree Ram Koti Naik, AEE, PRSD Madhira, Dt. 30.1.2014.

He submitted objection that he was appointed under LR 1993 for ST candidates and have completed probation by 05.10.1995 and temporary Assistant Executive Engineers appointed during 1990-1995 were not found in the seniority list communicated dated 1.4.2008 and their services were not regularized at that time and also submitted that due to wrong interpretation of GO.Ms.No.262,Dt.17.6.2006 for the dual benefit to the temporary Assistant Executive Engineers 1990&1991, their services were regularized and placing them before APPSC ST regular candidate recruited through LR 1993 batch is not correct.

The above objection of the individual is examined and services of temporary Assistant Executive Engineers were regularized as per G.O.Ms.No.262, Dt.17.6.2006 below the last regular Assistant Executive Engineer appointed through APPSC prior to promulgation of Act 2/94. The individual was repatriated from Zone-I to Zone-V under 610 and he has attracted the rule 16(h) as he has passed the Account Test belatedly and his date of regularization is arrived as 13.5.1995 as per Rule 16 (h) APSSS Rules. As per orders of Government and Hon'ble APAT in OA No.10934/2008,OA No.6500/2006 and batch and Hon'ble High court orders in W.Ps No.22978batch to 18.1.2014 in super session of earlier seniority lists duly applying rule 16(h) of APSSS Rules. An Employee on his entering into the service is expected to know the rules of the Dept. and it is need not to mention in the appointment order.

Hence objection of the individual is here by rejected.

4.Sri R.Shailnder, DEE PR PIU Sub Division Utnoor, Nirmla Division, Adilabad

He has submitted that he was appointed as Assistant Executive Engineer and joined duty on 27.7.1992AN through APPSC and said that it is not possible for any employee to pass the departmental test retrospectively if probation is commenced retrospectively and seniority has to be considered on only merit and ability and has to be considered the rank assigned irrespective of commencement of probation and submitted that there is no induction training given by department and department has to inform well in advance 6 months before to pass the Account Test. He also objected regularizing the services of temporary Assistant Executive Engineers 1990-92 as per G.O.Ms.No.262,Dt.17.6.2006 and placing them below the APPSC candidates incorrect and terms & conditions contained in the G.O. 234 & 262 to make good of short fall of roaster system not observed in the recruitment altogether. He also said that rule 16(h) if applied has to be applied to the APPSC 1992 batch and notified vacancies are to be filled by APPSC only and requested not to alter the APPSC seniority and penal clause 24(c)/16(h) shall not be applied.

As per the directions of courts, and as per orders of regularization of temporary Assistant Executive Engineers by Government the provisional seniority was prepared duly applying rule 16(h) to all the Assistant Executive Engineers appointed through APPSC and regularized temporary Assistant Executive Engineers as per orders of Government. Permission was obtained from Government regarding date of commencement for those Assistant Executive Engineers who have passed Accounts belatedly and who have attracted the rule 16(h) and prepared the provisional seniority

list. Roaster for the Assistant Executive Engineers appointed is being maintained separately. As per orders of Government and Hon'ble APAT in OA No.10934/2008,OA No.6500/2006 and batch and Hon'ble High court orders in W.Ps No.22978 batch to implement the rule 16(h), the provisional seniority list was communicated on 18.1.2014 in supersession of earlier seniority lists duly applying rule 16(h) of APSSS Rules. An employee on his entering in to the service is excepted to know the rules of the Dept. and it is need not to mention in the appointment order.

Hence objection of the individual is here by rejected.

5. Sri S.Rabbanibasha, Dy Executive Engineer:

He has submitted that he was appointed as Assistant Executive Engineer and joined duty on 22.5.1992 through APPSC and said that he was informed on 19.9.1996 that he was placed on probation with retrospective effect from 1.3.93 and was asked to pass Accounts test by the time probation period was completed, failing which the probation is liable to be extended or revised in terms of General rule 24(c) and 26 and due to delay of more than 4 years his opportunity to pass the Accounts Test within probation period was denied. He further stated that he has passed the Accounts Test within 2 years period from the date of communication of orders of commencement of probation and results published in Special Bullettin 1/97 and said that changing his seniority due to belated passing of Accounts test is not correct.

His objection is examined and he is informed that as per orders of Government and Hon'ble APAT in OA No.10934/2008,OA No.6500/2006 and batch and Hon'ble High court orders in W.Ps No.22978batch to implement the rule 16(h), the provisional seniority list was communicated on 18.1.2014 in supersession of earlier seniority lists duly applying rule 16(h). of APSSS Rules. An employee on his entering in to the service is excepted to know the rules of the Dept. and it is need not to mention in the appointment order.

Hence objection of the individual is here by rejected.

6. Sri V.Koteswara Rao, Dy Executive Engineer, PIU SD Aswaraopeta:

The individual submitted as follows:

In GO Ms.No.262,PR&RD(Est.III)Dept.Dt.17.6.2006 Govt. Have directed ENC PR to regularize the services of AEEs who were appointed during the period 1990-92 below the last regular Assistant Executive Engineer appointed through APPSC prior to promulgation of Act 2/94. The request of AEE who were appointed during the year 1990 for regularisation of their services from the date of their joining service was rejected vide Govt.Memo.No.160-83/Estt.III/A1/2006-4,Dt.4.10.2007. and they have filed OA No.6187/2008 and H'ble APAT set aside the government memo and directed to regularise service from the date of initial appointment ie., 25.3.1990 as was don in case of Engineer Irrigation Dept. **Assistant** Executive Ms.No.145,I&CAD,Dt.2.12.2005 who were appointed prior to Act.2/1994 and said that he has filed CA No.1268/2012 for implementation of orders in OA No.6121/2008. He further stated that Assistant Executive Engineers appointed during the year 1987-88 through Employment Exchanges were regularized from the date of joining into service vide GO Ms No.388,PR&RD(Estt.III)Dept.Dt.12.11.2010 and the services of Assistant Executive Engineer appointed during 1993-95 i.e., after promulgation of Act.2/94

were regularized from the date of joining into service vide GO Ms.No.334 and said that the benefit of seniority to the candidates appointed from 1990-92 was extended to the candidates appointed from 1993-95, but in fact the services of Assistant Executive Engineers who were appointed during the year 1990-92 were not regularized from the date of joining into service. He said that has passed the Account test for PWD officers and subordinates test on 2.1.1991. and said that he is eligible for commencement of probation above 1992 batch as per OA No.6182/2008.

In view of the above objection, he is informed that Govt., vide G.O.Ms.No.234,PR&RD(Estt.III)Dept. Dt.27.6.2005 issued orders to regularize the services of all temporary Assistant Executive Engineers who were appointed in between 1990-95 below the last regular candidates in the category of Assistant Executive Engineer excluding their temporary appointment from the purview of APPSC under the proviso to clause 3 of the Article 320 of the constitution of India and later Govt., in partial modification of G.O.Ms.No.234 the orders were issued vide G.O.Ms No.262, directed Engineer-in Chief, PR to regularize the services of Assistant Executive Engineer who were appointed during the period 1990-92 below the last regular Assistant Executive Engineer appointed through APPSC prior to promulgation of ACT 2/94. Govt. Vide Memo No.160-83/Estt.III/A1/2006-4,Dt.4.10.2007 have rejected the request of individual for regularization of the date of joining in service and Hon'ble APAT has set aside the Govt., memo in OA No.6187/2008 and Hon'ble High court in W.P.M.P.No.9254 of 2013 in WP No. 7369 of 2013 filed by ENC PR has issued interim orders as follows.

INTERIM ORDER:

"There shall be interim suspension as prayed for Notice"

Hence the provisional seniority was prepared and confirmed subject to out come of court orders pending

The above four individual have submitted objection on provisional seniority communicated vide this office memo no. Dt.18.1.2014 as follows:

Their objection is that they were appointed in August 1991 under CERP programme in zone VI under Non Local quota and their services were regularised w.e.f. 8.5.1993 in Zonve VI. Further submitted that they were subsequently repatriated to Zone V as per orders of G.O.Ms.No.610 and placed below AEEs(Sri P.Ram Mohan, Sri G.V.Koteswara Rao and Sri A.Srinivasa) who were appointed under CERP programme during December 1992 in Zone V which is injustice and requested to place their names below 1991 CERP batch appointed in August 1991 and above December 1992 CERP AEEs appointments in Zone V ie., (Sri P.Ram Mohan, Sri G.V.Koteswara Rao and Sri A.Srinivasa).

The objections are examined and they are informed that the nature of appointments under CERP are one and the same. But the date of regularization of

same batch is different in one zone to other zone and to protect the seniority they were placed below the regular Assistant Executive Engineers appointed under same programme in Zone V and batch, but not according to their date of regularization in the zone they were originally appointed. All the Assistant Executive Engineers were appointed under same programme and regularization of Assistant Executive Engineers appointed in Zone V under CERP programme as per GO 262 dt. 17.06.2006 has be taken into consideration and is to be protected and hence the Assistant Executive Engineers repatriated under 610 were placed below the names of Zone V.

Hence objection of the individuals are here by rejected.

8.a) Sri B. Chandru, Assistant Executive Engineer, PIU SD, Wyra. b) Sri P.Vidhya Sagar, Assistant Executive Engineer, PIU SD Madhira

The above two individual have submitted objection on provisional seniority communicated vide this office memo no. Dt.18.1.2014 that they were appointed as AEE through APPSC under LR 1993 for ST candidates and they have been placed on probation on 05.10.1995 and temporary Assistant Executive Engineers appointed during 1990-1995 were not found in the seniority list communicated dated on 1.4.2008 and their services were not regularized at that time and also submitted that temporary Assistant Executive Engineers 1990&1991, as per the PRES Rules there is no specific quota indicated for accommodating the temporary AEES except through direct recruitment. Hence including temporary AEES in the panel is irregular. The applicants said that they were entered in PRED on 26.05.1993 and probation was commenced on 10.05.1995, which is much below 16(H) Rule commenced in 1996. Hence they did not fall under 16 (H) Rule. Hence modify their position in the initial cadre of AEE.

In view of the above objections of individuals are examined and informed that services of temporary Assistant Executive Engineers were regularized as per G.O.Ms.No.262, Dt.17.6.2006 below the last regular AEE appointed through APPSC prior to promulgation of Act 2/94. The individuals were repatriated from Zone-II to Zone-V under 610 and they have attracted the rule 16(h) as they have passed the Account Test belatedly and their date of regularization is taken on 05.10.1995. As per orders of Government of H'ble APAT in OA No.10934/2008,OA No.6500/2006 and batch and Hon'ble High court orders in W.Ps No.22978 batch to implement the rule of earlier seniority lists duly applying rule 16(h of APSSS Rules. An individual on his entering in to the service is expected to know the rules of the Dept. and it is need not to mention in the appointment order.

Hence objections of the individuals are here by rejected.

9. S.Rajkumar, Dy Executive Engineer, PIU Mahabubad:

He has submitted his objections on seniority of Assistant Executive Engineer communicated on 18.01.2014 (advanced copy) with out signature.

Hence his case can not be examined.

The Placement of Assistant Executive Engineers of G.O.262 batch, who were repatriated from other zones to zone-V were given as per the date of birth without

disbursing the seniority of Assistant Executive Engineers in their respective appointed zones.

The provisional seniority list of Assistant Executive Engineers of zone-V communicated vide reference 20th cited is finalized duly considering various objections and final seniority list as per the annexure enclosed is here by confirmed subject to out of OA/WP/SLP if any pending in Hon'ble APAT/ High court and Supreme Court.
