

ESTABLISHMENT - PR&ED - Re-organisation of Panchayati Raj and Rural Water Supply Circles - Orders - Issued.

ORDER :-

The Engineer-in-Chief, P.R. Hyderabad in his letter fourth read above has submitted that the R.W.S. wing of Panchayati Raj Department is having (8) Circles covering 22 districts, (6) Circles of them have a jurisdiction of (3) districts each and informed that the Government of India have approved (35) Projects at an estimated cost of Rs.465.00 crores and in R.W.S. 14,523 schemes have been taken up at an estimated cost of Rs.522.27 crores. He has also informed that during the monthly review meeting on 17-10-1997 the Hon'ble Chief Minister has directed that all the schemes shall be completed before the end of the financial year 1998-99 and as a follow up action, during the Meeting held with Minister (PR&RD) on the implementation of R.W.S. Programme, it is decided to reduce the jurisdiction of Superintending Engineer (RWS) to (2) districts by way of rearrangement of the existing circles.

2. Accordingly, the Engineer-in-Chief, (PR) Hyderabad. Has proposed the following circles for Rural Water Supply Wing in the Panchayati Raj Department.
