**ORDER :**

In the G.O. 3<sup>rd</sup> read above among other items orders were issued enhancing the technical sanction powers of Executive Engineers and Superintending Engineers from Rs.30,000/- to Rs.1,00,000/- and Rs.1,00,000/- to Rs.5,00,000/- respectively for according technical sanction of electrical works under the jurisdiction of Head Quarters Circle, Hyd. limiting the said powers only in respect of the Secretariat buildings, Hon'ble C.M's Office buildings, Assembly buildings, MLA quarters and Raj Bhavan.

2) The C.E., R&B, Buildings, Hyd. in his letter 4<sup>th</sup> read above has stated that for according technical sanction of electrical works in buildings other than the above buildings, the powers delegated for electrical works in the G.O. 1<sup>st</sup> read above are still being exercised and no further enhancement orders were issued by Govt. But the cost of material and labour component has increased many times during the last 3 decades and consequently the value of the electrical estimates has also increased. Due to the limited powers of sanction, previously an estimate which was usually accord technical sanction by the E.E. (Electrical) has now got to be accorded technical sanction by the Superintending Engineer (Electrical), or Chief Engineer, thereby much time is being consumed and resulting in delay in execution of the electrical works. He has also stated that so far as the electrical works in the dept. are concerned, unlike other civil works, they are of very urgent nature and taking up the electrical repairs and also restoration of power supply in immediate succession is an essentiality . The dept. usually executes electrical works in govt. buildings, official residences of V.V.I.Ps. and the electrical works are to be taken up on top priority and to be completed within time schedule.

3) The C.E. (R&B), Buildings, Hyd. in the reference 5<sup>th</sup> read above has informed that it is very essential to enhance the technical sanction powers of Electrical works for timely approvals and to avoid coming to Hyd. for getting the approval of C.E. (R&B) Buildings, for the works costing above Rs.1,00,000/-. It is loss to govt. by paying TA and DA to the staff deputed to Hyd. and also hampers the office work. The C.E., R&B, Buildings, Hyd. has therefore recommended to extend the enhanced technical sanction powers issued in para 4(iv) of G.O.Ms.No.257, dated 23.11.2005 to all the Govt. buildings in the State and to all the E.E. (Electrical and Superintending Engineer (Electrical) in the R&B Dept. for smooth and quick actions for timely completion of the works.

4) In the G.O.6<sup>th</sup> read above, orders were issued constituting the Committee to recommend on the need of extension of enhanced technical sanction powers to execute the works on all the Govt. buildings in the State duly keeping in view of the volume of work and the C.E. (R&B, Buildings, Hyd. was requested to send recommendations of the Committee to Government immediately.

5) The C.E. (R&B), Buildings, Hyd. in the reference 7<sup>th</sup> read above has stated that the committee has recommended to extend the enhanced of technical sanction powers to E.E. (Electrical) and S.E. (Electrical) for Electrical works to all the Govt. Buildings in the State from the existing limitations of Rs.30,000/- to Rs.1,00,000/- and Rs.1,00,000/- to Rs.5,00,000/- respectively, for speedy execution and smooth functioning of the system for timely completion of the electrical works.

6) After careful examination of the above recommendation of the committee the Government hereby extend the enhanced technical sanction powers for Electrical Works, issued in the G.O. 3<sup>rd</sup> read above to all the Govt. Buildings in the State and to all the E.E. (Electrical ) i.e. E.E. (R&B), General, Hyd. E.E. (R&B), Electrical Rural Division, Hyd., E.E. (R&B) Electrical Guntur, E.E. (R&B) Electrical Kurnool and S.E. (Electrical) in the (R&B) Dept. for smooth and quick action for timely completion of the works and to avoid adverse comments.
