In the reference 1<sup>st</sup> cited, the Government permitted the ENC, PR, Hyderabad to implement the Orders of the Hon'ble APAT , dated.22.08.2014 in OA No. 5831/2013 & Batch cases, duly following the prescribed procedure.

In the reference 2<sup>nd</sup> cited, the Hon'ble APAT in its common orders dated 22.08.2014 in OA No. 5831/2013 filed by Sri J. Hari Babu, SE, RWS, Karimnagar into consideration for sake of convenience and set aside the revised seniority list of AEEs and Dy.EEs and integrated seniority list of DEEs prepared during 2013 in so far as they relate the applicants in the OAs and under point No. 2, the Hon'ble APAT, pronounced that the applicants are entitled to reckon the last Thursday of January,1991 i.e., 31.01.1991 as the date on which they deemed to have passed Account test and consequently their commencement of probation should be taken as 31.01.1989.
